The EcoVadis sustainability assessment methodology is central and is an evaluation of how well we at VAN AS have integrated the principles of sustainability/CSR into our business and management system. The EcoVadis methodology is based on international sustainability standards, including the Global Reporting Initiative, the United Nations Global Compact and ISO 26000, which covers 200 spending categories and 160+ countries.

- VAN AS is committed to promoting sustained, inclusive and sustainable growth, full and productive employment and decent, safe work for all. We subscribe to the Universal Declaration of Human Rights. This is how we ensure that we treat each other with honesty and dignity.
- We strive for economic growth and creating more jobs;
- Our organization contributes to SDG 16 by creating a safe working environment for our employees. We do this by concluding maintenance contracts, legal inspections and maintenance of our machines, but also energy certificates, evacuation plans, emergency response and storage of chemicals are included in this.
- Security also means that data is handled with care. This can be data from customers, but also internal data within our organization. We also comply with the AVG Privacy Act.
- The legislation is strictly observed.



We strive to reduce our environmental impact by, for example, applying biobased materials with a minimal CO<sub>2</sub> footprint.

- The VAN AS business premise has solar panels which provide 200.000 kWh;
- 100% of our used electricity is green and comes from hydro-electric powerplants;
- All lamps in the building are LED;
- We are committed to sustainable innovative developments such as replacing our presses in presses with UV drying technology as they have less energy consumption;
- We mostly print on FSC paper or recycled paper;
- We offer plastic printing on recyclable plastic or on already recycled plastic.



- VAN AS strives for an environmentally friendly management of chemicals. We significantly limit our emissions to air, water and soil to minimize their negative impacts on human health and on the environment.
- We have an extensive product range with sustainable alternatives;
- We regulate four waste streams, namely paper, polypropylene, PVC and other waste;
- Significantly limiting waste through prevention, reduction, recycling and re-use;
- VAN AS deals responsibly with auxiliary materials and raw materials, waste, water, air and energy.
